Dear MR MOUSUM,

We welcome to your application dated 29/03/2021, and subsequent interview you had with us, we are pleased to appoint you in our organization as **JUNIOR RELATIONSHIP EXECUTIVE** with effect from 03/05/2021 on the following terms and conditions:

1. You shall be initially on probation for a period of One (1) year, which may be extended for such further period(s) as the Organization may in its sole and absolute discretion, deem fit and proper. You shall not be deemed to be confirmed in the services of the Organization, after the completion of the said probationary period or the extended probationary period, unless you are specifically informed in writing to that effect by the Organization. 8. During your employment with the organization, you shall be subject to such rules and regulations and the employee code of conduct as are made by the organization from time to time at its discretion, whether they are individually notified to you or not.

9. If you resign or leave without sanctioned leave or without the leave originally granted or subsequently extended, you shall lose pay on the job held by you automatically, unless you return within 7 days of the commencement of the absence or expiry of the sanctioned leave as the case may be, and explain to the satisfaction of the Management, in writing, the reasons of the unauthorised absence and intend to return on the expiry of the leave already sanctioned, as the case may be.

10. 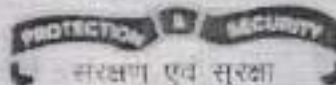




